

West Nile Virus on the Rise

The Sacramento-Yolo Mosquito & Vector Control District announced that more evidence of West Nile virus activity (WNV) has been detected in widespread locations throughout Sacramento County. Areas where WNV activity is intense include North Highlands, Fair Oaks and Elk Grove. "The very hot temperatures of the last few days have increased the production of mosquitoes and West Nile virus is on the rise putting the public at a higher risk" said Gary Goodman District Manager. "We're very concerned about the increased level of activity in these areas. While WNV activity is increasing throughout California, Sacramento County leads the state with the highest number of dead birds and mosquito samples that have tested positive for West Nile.



The Centers for Disease Control recommends using an insect repellent that contains the ac-

tive ingredients DEET, Picaridin, IR3535 or the plant based Oil of Lemon Eucalyptus. Always follow label directions when applying repellent.

In response to the ongoing WNV activity, the District will continue surveillance efforts through testing of mosquito samples and dead bird reports as well as controlling adult mosquitoes with ground fogging in areas of concern. If a decision is made to conduct aerial treatments, media will be notified immediately so information can be disseminated to the public. http://www.fightthebite.net/spraying-update

Help the Sacramento-Yolo Mosquito & Vector Control District protect you and your community by reporting dead birds and squirrels. The District and the California Department of Public Health use dead bird reports to help identify increased West Nile virus activity in an area. Crows and magpies are particularly susceptible to the disease, so they make excellent early warning sentinels for virus activity.

May Budget Report

Actual year-to-date income of \$1,347,449 versus year-to-date budgeted income of \$1,358,145 produced a negative income variance of \$10,696.

Actual year-to-date operating expenses of \$380,157 versus year-to-date budgeted expenses of \$539,315 produced a positive expenses variance of \$159,158.

The two combined variances produced a positive year-to-date variance of \$148,462.

President's Letter

Hello, everyone:

Water conservation is still in the news, and Nepenthe homeowners should be aware of water conservation rebates available from the City of Sacramento. For example, a \$125 rebate is available for replacing an older toilet with a water conserving model. I recently submitted an application for a \$250 rebate for replacing the two toilets in my own home. (Note that an inspection by the city of the old toilet before removal is required.) Other rebates are available for conversion of patio irrigation to drip and for installing a "smart" controller. More on those later as I check them out for my own patio.

In the recent election, the bylaw amendment to eliminate the need and cost of an election when there is no contest initially failed to pass by just a few votes. (It required 50 % plus one of all homeowners to pass.) The Board took advantage of a provision in the law permitting a 30-day extension of the voting period, to allow additional ballots to be submitted. The additional ballots that came in had enough yes votes to pass the provision, which is now in effect

As I pointed out in last month's letter, many newer residents are unfamiliar with the two different administrative structures between Nepenthe and the Villages in Campus Commons, each with its own clubhouse and amenities. These separate structures were established by the two separate developers when the Campus Commons area was developed in the 1970's,

with little evidence on the ground of the line between the two. In order to minimize the confusion, I had proposed that we use the terms 'Nepenthe at Campus Commons' and 'Villages at Campus Commons' when referring to activities relating to either one, and so residents are clear in which portion they take place. Nextdoor posts should also indicate whether Nepenthe or Villages, since so many deal with administrative issues for one or the other.



Some time ago the Board approved a policy of placing park-style benches at locations which encourage walking by providing places to rest. The ad hoc bench committee recommended 19 locations along walks

with open space vistas throughout Nepenthe. Benches are to be funded by a combination of modest reserve fund expenditures and by donations of benches by residents wishing to remember a loved one. The first of these benches is now in place along the handicap ramp in front of the clubhouse, which I had the pleasure of donating in memory of my late wife, Rita Gennis. If others are interested in making a lasting memorial by donating a bench, please contact the office.

Manager's Report

So much going on! As usual! Here are some updates on what we've been working on:

Landscape: Subterranean drip irrigation in Zone 3 is almost complete. This project will eliminate run off in the alleys which has been a long standing problem in the association. To reward our water saving efforts, the City of Sacramento will be providing a rebate on our purchases of materials. Saving water AND money! That's called WINNING!

Each week I walk one of our seven zones with the Grounds Committee and George Procida, the owner of GP Landscape. We create a specific work plan for areas that need attention. George takes photos of the area, adds notes to the photo of what we agreed upon and send that back to me to review once more with the Grounds Chair to ensure that what we talked about in the field agrees with the notes. A work order is placed and before the next walk in that area, the Grounds Steward confirms the work was completed satisfactorily. If you would like to

review the Walk Notes for your area, you are welcome to come by the office to look through the binder. If you have specific requests for shrub replacements in your area, feel free to contact me via email at bettsi.ledesma@fsresidential.com or call me at the office at (916) 929-8380.

Tennis/Pickleball Courts: The Board accepted a bid from NorCal Asphalt (subject to some negotiation) to reseal the

courts at the clubhouse and on Commons Drive. Additionally, the Pickleballers will be thrilled to have two dedicated courts at the clubhouse as well as the two multi-use courts already there. This entire project will cost \$26,928, \$2,388 less than the Reserve allocation.

Pool furniture: The homeowners who enjoy the Dunbarton and Elmhurst pools will be so pleased when they see the brand new furniture being ordered! The Board approved the purchase of 18 lounges and 12 chairs total for the two pool decks. They are exactly the same as the furniture at the clubhouse pool. When the new furniture arrives, the old pieces will be offered for sale on www.nextdoor.com and then www.sacramento.craigslist.org.

Parking Passes: You've spoken, we've responded. Beginning immediately, the private street guest passes available outside the clubhouse door are for emergency use only and are only good for ONE night. If your guest will be staying longer, please

come in during business hours and we will be happy to provide your guest with a pass that will be good for up to two weeks.



Concrete Work is completed. Phase II Siding Repair and Painting are in the home stretch! Phase III will be beginning soon, so we will be announcing a homeowner informational meeting in the next few weeks.

This Mosquito Dunks can help control mosquitos in your water features.


Here is a picture of the product for mosquitos. It is carried at Home Depot and Emigh. You can break into smaller pieces for shallow or small pools.

- Recycling, Garbage, and Illegal Dumping
- Streets & Lighting
- Vehicle complaints

If a mobile app is not your "thing", you can always call 311 on any phone and speak to a live customer service rep. They will take your report and route it to the appropriate department.
