IES is pleased to present this proposal to complete repairs for AC Unit #1. IES proposes to replace and/or rebuild cracked condensate trap/drain line(s). IES will install new material for drain and anchor as needed. Once repair is complete, IES will perform startup and verify proper operations and draining.

Also included in Scope of Work:

- Replace strap,
- blower out condensate line
- repair suction line insulation
- repair hole in supply vent

Benefits:

Once repairs are made system will once again be within proper operating parameters. Once repaired the risk of further system failure and water damage to space below will be reduced. Safe and reliable operation will be established.
